

## **Program Conditions and Statement of Responsibility**

**PAYMENT:** A deposit of US **\$500** per person is required to secure your place on the program along with the registration form. (Full deposits will be refunded only if Biblical Resources, LLC (BR) Withdraws the offer of the program). Final payment is due to BR no later than 65 days prior to departure date. BR welcomes installment payments until final payment date of departure.

**SPECIAL NOTE:** BR cannot be responsible for any increase in airline fares, added taxes or fuel surcharges prior to the date of tickets being issued by the airlines.

**CANCELLATION:** All cancellations for any reason and at any time must be received in writing and will be subject to a \$200, per person, administration fee. Cancellation between 90-65 days of departure will be subject to additional loss of some non-recoverable sums from independent providers of land and air services. **No refund is available 65 days or less prior to departure.** (Full refund will be issued if BR withdraws the offer of the program). Air tickets once issued are non-refundable. However, it may be used within a year of its travel date according to airline policies.

**INSURANCE:** We highly recommend applicants consider purchasing trip cancellation insurance because of the possibility of loss of large sums of money if cancellation occurs within the last 65 days prior to departure.

**YOUR ACCOMMODATION:** Price is based on two persons in a room in a four-star hotel or comparable. A supplemental room charge will apply to individuals enrolling without a roommate. If you are interested in BR assigning you a roommate, all attempts will be made to do so, but it is not guaranteed. All single rooms are subject to availability and are often smaller than normal twin rooms.

**YOUR MEALS:** Will be half board throughout the program (unless otherwise noted) and will include breakfast and dinner each day.

**YOUR TRAVEL PROGRAM:** Includes the services of an English speaking scholar/lecturer local guide (where required), notebook of diagrams & maps, hotels, bus tips, entrance fees and transportation to sites as listed in the program.

**YOU WILL BE TRANSFERRED** with the group from the airport to hotel(s) and to the airport for departure. Non-group flight participants handle their own ground arrangements unless arranged are made with BR prior to departure.

**YOUR LUGGAGE** is restricted in size, weight and shape by the airlines. You may contact them if you need the specific restriction or possible rates applied.

**PASSPORT REQUIREMENTS:** A valid passport, good for at least 6 additional months from date of return (see itinerary) is required of all participants.

**YOUR AIRLINE ARRANGEMENTS:** A fuel surcharge may be imposed by the airlines and other suppliers. Should this occur, the amount of the surcharge will be paid by the passenger. Your tickets must be finalized with the airlines and your ticket written a minimum of 45 days prior to departure in order to guarantee the group fare. Once your group ticket has been issued airline policies go into effect and it cannot be transferred or refunded to the passenger by the airlines. However, depending on airline

policies, it may be used within a year of its original travel date. Air transportation will be jet economy class aboard carriers which may utilize non-refundable, non-transferable tickets to/from your destination for groups flying together for the entire itinerary.

**SPECIAL NOTE:** The terms of airline group rates used by BR does not permit usage of frequent flyer miles and upgrading to business class. BR will offer individuals a discount of \$950 for the purchase of their own international flights for those reasons.

**ITINERARY LENGTH:** Your flight times are subject to change without advance notice. BR is not responsible for changes and delays in airline schedules and cannot reimburse passengers for expenses resulting from airline delays. Because airlines often change flight times and dates at the last minute, BR strongly recommends the purchase of domestic tickets, which can be changed without heavy fees and penalties. If airline(s) change flight schedules, BR reserves the right to lengthen or shorten the itinerary accordingly, and whenever possible, you will be notified. If airline changes incur an extra overnight, you will be charged (per night) per hotel rates.

**NOT INCLUDED** in the price are lunches, drinks and coffee during or after meals (unless specified in program), tips for personal favors, laundry, excess baggage and forwarding of baggage, transfers other than with the group, and optional travel insurance (recommended).
